## New Treasurer

Robert M. Dick, Q.C.

Robert Martin Dick, Q.C. was born in Vernon, B.C. many more years ago than he cares to admit. He spent his childhood in Vernon and graduated from Vernon Senior High School before heading off to UBC for his B.A. and L.L.B. While at UBC Bob met and married Maureen Dilworth and that union produced two children, Robert Dilworth Dick, now 25 and Katherine Grace Dick, now 22. Maureen convinced Bob that Prince George would be a good place to raise children and make a lot of money. She was partly right. His kids are good kids. Bob articled at Wilson, King & Company in Prince George and was called to the Bar in 1967. He practised at Wilson King & Company continuously from 1967 until 1983 when he became a Bencher. ## The Big City

As a person who has worked with Bob Dick and witnessed his years of service to the bar outside his home town, I was asked to supplement this article with a view of that part of your new Treasurer's career. I was astonished to learn that Bob actually finds time to do things in Prince George. Most of us thought he maintained his principal residence in Vancouver and only travelled to Prince George to make money.

Long ago Bob decided there was more to practising law than client development so he decided to get involved in his local bar association. He ended up as President of the Caribou Bar Association. Once bitten he was consumed by a lust for a service to the profession.

Realizing that Prince George was not really the centre of the province, he successfully sought election to the Provincial Council of the Canadian Bar Association where he served for the maximum term of six years. He took an active role in the CBA subsections (becoming the chairman of the Professional Services Committee) and was elected to the Executive Committee for three years.

Having exhausted this method of depriving his firm of billable hours, Bob became a Bencher for the Country of Caribou in January 1983.

Upon becoming a Bencher, he became involved in many committees including the Committee to Amend the Supreme Court Rules, the specialization Committee, the Planning and Professional Services Committee, the Law Society's Centenary Committee and the Finance Committee, to name just a few.
