rant was born in Regina but soon moved to Vancouver. He is a UBC graduate (1973) and articled at Davis & Company where he has continued his practice ever since.

Grant appears to have established the UBC Law School second-year record for attending the fewest classes and still passing his year.

His university and law school activities included being a member of the Dean's Selection Committee and the Articles Committee, external vice-president, president of his fraternity, and president of the Student Association.

In practice, Grant has specialized in the insolvency field, where he has become an acknowledged expert. In the late 1970s he developed the largest foreclosure practice in British Columbia, and became a leading expert on receiverships and bankruptcies.

Since his call to the Bar, he has not lost his proclivity for joining things. These activities include being the founding chairman of the Insolvency Section of the B.C. He is or has been a member of the board of the Vancouver Chamber Choir, founding president of the Bard on the Beach Theatre Society, a director of the Vancouver Playhouse Theatre Society, and a member of the Advisory Board of the Canada Pacific Repertory Theatre Society.

On the municipal front he has been a member of the Board of Variance and chairman of the Vancouver City Planning Commission.

In his spare time he has dabbled in things political. He was president of the Civic Non-Partisan Association and president of the Vancouver Centre Riding Association for the Liberal Party, he ran two federal campaigns in Vancouver Centre for Art Phillips, and he was the president of the British Columbia Liberal Party.

Grant golfs, not well and not often.

On one occasion his errant tee shot on the Marine Drive course landed well off the fairway, coming to rest in the middle of what appeared to the unsuspecting golfer to be a dried-up creekbed. Grant's near-fatal attempt to retrieve the ball is the genesis of his "nom de golf", the Mud Turtle. Grant buys books at a pace that vastly exceeds his ability to consume them, making him a good person to borrow from. He has most of the new releases in hard cover and soon forgets what he lent to you. He is a good dinner guest; he always brings more beer and wine than he drinks. He is a movie buff and has seen every movie ever made.
